27th February 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Miscellaneous Skin Preparations Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Dapsone 5% w/w 20gm, Methylprednisolone acetate 2.5mg, neomycin sulphate 2.5mg, aluminium chlorhydroxide 100mg, sulphur 50mg per ml 20gm, Aloe vera, jojoba oil, vit E 50gm, Aloe vera, orange oil, tea tree oil 50gm, Aloe vera, neem extract, tulsi extract, tea tree oil 50gm, Aloe vera, neem extract, tulsi extract, tea tree oil, lavender oil 50gm, Allantoin 2% w/w, coaltar 5% w/w 20gm, Zinc oxide 15% v/v, mepyramine maleate 2% v/v, glycerine 5% v/v 60ml, Reformulated aminacrine hcl 0.1g, thymol 5mg, emulsion base to 100mg 10gm, Aminacrine 0.1gm, cetrimide hcl 0.5gm 10gm, Coat tar 4.25% v/v, salicylic acid 2% v/v 60ml, Kojic acid 0.75% w/w, vit c 2.5% w/w 15gm, Podophyllotoxin 5mg/ml 3.5ml, Coal tar 5% w/w 100ml, Sodium sulphacetamide and sulfur lotion 60ml, Vit e 0.5% w/w, alovera extract 10% w/w 50gm, Tocopherol aceate 1% w/w, propylene glycol 5% w/w, liquid paraffin 60gm, Nitrofurazone 0.2% w/w 20gm, Vit a as palmitate 1500 iu per ml 60ml, Metronidazole 10mg/gm 30gm, Trichlorocarbanilide 75gm, Benzocaine 2% w/w, lindane 1% w/w 25gm, lindane 1% w/w 100ml, Potassium iodine 5% w/w, metronidazole 1% w/w 15gm, Hamamelis water 5% w/w, lignocaine 2% w/w, zinc oxide 10% w/w 20gm, Methotrexate 1% w/w 10gm, Aloe extract 10% w/w, tocopheryl aceate 0.5% w/w 25gm, Tacrolimus 0.03% w/w 10gm, Tacrolimus 0.1% w/w 10gm, Tetraethylthiuram monosulphide 5% w/w 75gm, Octinoxate 7.5% w/w, avobenzone 2% w/w, oxybenzone 3% w/w, zinc oxide 2% w/w, phenenoxyethanol 1% w/w 50ml.
