The company is said to have approvals for different combinations of the drug, i.e. Metronidazole 200 mg, Metronidazole 400 mg, Metronidazole 200 mg/5ml (60ml), Metronidazole 500 mg/100ml, Metronidazole 100 mg/5ml (60ml), Metronidazole 400 mg, Furazolidone 100mg, Simethicone 50mg, Metronidazole 100 mg, Furazolidone 30mg (60ml), Metronidazole 400 mg, Diloxanide furoate 500mg, Simethicone 100 mg, Metronidazole 300 mg, Furazolidone 100mg, Metronidazole 75 mg, Furazolidone 25mg 60ml, Metronidazole 200 mg, Diloxanide furoate 250 mg, Metronidazole 200 mg, Furazolidone 50 mg, Metronidazole 100 mg, Furazolidone 30 mg/5ml (60ml).
