23rd January 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Melanizing Agents Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Psoralen 10mg, Psoralen 10mg/30gm, Psoralen 0.75% w/w 25ml, Methoxsalen 0.75% w/w, para aminobenzoic acid 2% w/w 25gm , Each gram contains extract of 0.1 gm of fresh human placenta total nitrogen not more than 0.25% w/w 20gm .

The generic manufacturing strategies of New Drug Melanizing Agents and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
