The company is said to have approvals for different combinations of the drug, i.e. Methylergometrine maleate 0.2mg/1ml, Methylergometrine maleate 0.125mg, Methylergometrine maleate 0.5mg, oxytocin 8.33mcg/1ml, Methylergometrine maleate 0.125mg.

The generic manufacturing strategies of New Drug Methylergometrine and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
