4th March 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for MMR (measles, mumps, rubella) virus vaccine Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Each dose contains not less than 1000 TCID of measles virus, 1000 TCID of rubella virus, 5000 TCID of mumps virus, Each dose contains live attenuated measles vaccine not less than 5000 TCID50, live attenuated mums vaccine not less than 5000 TCID50, live attenuated rubella vaccine not less than 4000 TCID50 0.5ml.

The generic manufacturing strategies of New Drug MMR (measles, mumps, rubella) virus vaccine and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
