27th February 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Miscellaneous Oropharyngeal Preparations Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Sod. Fluoride 0.05%, sod. Benzoate 2%, ticlosan 0.03% 150ml, Sod. Benzoate 2%, alcohol 7.5%, ticlosan 0.03% 300ml, Sod. Fluoride 0.05%, Sod. Benzoate 2%, alcohol 7.5%, ticlosan 0.03%, eucalyptus oil 0.05%, thymol 0.02%w/v 150ml, Camphor 5mg, chlorothymol 5mg, eucalyptol 125mg, menthol 55mg, terpineol 120mg, Thymol 0.06% w/v, ucalyptol 0.09% w/v, menthol 0.04% w/v, thanol 21.6% v/v 400ml, Hydrocortisone 0.02%, naphazoline nitrate 0.025% 10ml, Naphazoline nitrate 25mg, phenylephrine hcl 0.25mg, chlorbutol 0.35mg 10ml, Sod. pertorate monohydrate 480mg, Pot. Nitrate 5%w/w Sod. Monofluorophosphate 0.7%w/w 50g, Pot. Nitrate 5%w/w 50g, Chamomilla oil 15mg 30ml, Camphor 25mg, chlorothymol 5mg, eucalyptol 125mg, menthol 55mg, terpineol 120mg, Sod. Monofluorophosphate 0.38% w/w 50g, Thymol 0.06% w/v, eucalyptol 0.09% w/v, benzoic acid 0.15% w/v, menthol 0.04% w/v, ethanol 26% v/v 85ml, Pot. Nitrate 5% w/w, Sod monofluorophosphate 0.7% w/w, available fluoride 917 ppm 50g, Sod monofluorophosphate 0.1% w/w, zinc sulphate 0.025% w/w, alum 0.025% w/w 50g, Strontium chloride 10% w/w 100g, Choline salicylate 9% w/v, benzalkonium chloride 0.02% w/v 10ml.

The generic manufacturing strategies of New Drug Miscellaneous Oropharyngeal Preparations and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
