The company is said to have approvals for different combinations of the drug, i.e. Norfloxacin 400mg, Tinidazole 600mg, Norfloxacin 100mg, Tinidazole 75mg/30ml, Norfloxacin 100mg, Tinidazole 100mg/5ml, Norfloxacin, Tinidazole 30ml.
