16th July 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Oestrogen Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Conjugated estrogen 0.625mg, Ethinyl estradiol 0.035mg, cyproterone acetate 2mg, Estriol succinate 1mg, Estriol succinate 2mg, Ethinyl oestradiol 0.01mg, Ethinyl oestradiol 0.05mg, Ethinyl oestradiol 1mg, Conjugated estrogens 0.625mg, Conjugated estrogens 1.25mg, Conjugated estrogens .625mg/14gm, Ethinyl oestradiol 0.02mg, Oestradiol valerate 10mg/10x1ml.

The generic manufacturing strategies of New Drug Oestrogen and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
