12th August 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Oxyphenonium Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Oxyphenonium bromide 2mg, metronidazole 200mg, di-iodohydroxyquinoline 250mg, Oxyphenonium bromide 5mg, Oxyphenonium bromide 10mg, Oxyphenonium bromide 5mg, diazepam 2.5mg, magaldrate 40mg.

The generic manufacturing strategies of New Drug Oxyphenonium and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
