8th November 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Polymyxin b Eye Drops Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Polymyxin B sulphate 5000 i.u., chloramphenicol 10mg, dexamethasone sod. Phos. 1mg/ 3.5g, Polymyxin B sulphate 5000 iu, neomycin sulphate 1700 iu, gramicidin 25 iu per ml, Polymyxin B sulphate 10000 i.u., trimethoprim 1mg, thiomersal 0.005% per ml, Polymyxin B sulphate 5000 i.u., chloramphenicol 10mg, Polymyxin B sulphate 5000 i.u. 5ml, chloramphenicol 10mg, betamethasone 0.1% 5ml.

The generic manufacturing strategies of New Drug Polymyxin b Eye Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
