22th October 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Phenylephrine Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Phenylephrine hc 2.5mg, pheniramine maleate 2mg, thimerosal 0.02mg, benzalkonium chl. 0.2mg, menthol 0.25mg, eucalyptol 0.2mg/ml, Phenylephrine hc .25%, naphazoline nit. 0.025%, chlorbutol 0.35% /10ml.

The generic manufacturing strategies of New Drug Phenylephrine and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.

The Indian company is eminent manufacturer, supplier and exporter of Phenylephrine and various pharmaceuticals generics medicines in Tablets, capsules, Vial (injections), ampule, Strips and schedule packs etc.
