15th December 2009, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Progestogen-Estrogen Combination Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Levonorgestrel 0.15mg, ethinylestradiol 0.03mg, Levonorgestrel 0.25mg, ethinylestradiol 0.05mg, Each white tablet contains norgestrel 0.30mg, ethinylestradiol 0.03mg, each brown tablet contains ferrous fumarate 60mg, Lynestrenol 2.5mg, ethinylestradiol 0.05mg, Norethindrone 0.5mg, 7 white tablets. Ethinyloestradiol 35mcg, 7 pale peach tablets norethindrone 0.75mg, ethinyloestradiol 35mcg each 7 peach tablets, norethindrone 1mg, ethinylestradiol 35mcg, Norgestrel 0.5mg, ethinylestradiol 0.05mg, Ethynodiol diacetate 1mg, mestranol 0.1m, 6 brown tab (ethinyloestradiol 30mcg, levonorgestrel 50mcg) 5 white tab (ethinyloestradiol 40mcg, levonorgestrel 75mcg) 10 ochre tab (ethinyloestradiol 30mcg, levonorgestrel 125mcg).

The generic manufacturing strategies of New Drug Progestogen-Estrogen Combination and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
