Indian Pharmaceuticals Company Taj Pharmaceuticals receives FDA approval for Generic Rabies Vaccine

Mumbai - 29th January 2010 - Long Awaited approval for Rabies Vaccine given to Taj Pharmaceuticals from FDA to manufacture generic version

USFDA tentative approval for Various generic Medicines

29th January 2010, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Rabies Vaccine Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Inactivated rabies vaccine prepared on vero cells, Each ml contains human immunoglobulin max. 170mg with rabies antibodies 152 iu, aminoacetic acid as stabilizer 22.5mg/2ml, Each ml contains 200-400 iu of equine derived anti rabies immunoglobulins 5ml vial, Human derived anti-rabies immunoglobulin 300 iu per vial 2ml vial, Equine antirabies immunoglobulin 5ml vial, 2.5 iu inactivated rabies antigen (virus multiplied in chicken fibroblast cell cultures), stabilizer (1dose) TEN-haeacel and 0.1% glutamate q.s., Anti rabies vaccine on human diploid cells, Each freeze dried vaccine contains 1 dose such that the protective activity is > 2.5 iu, Inactivated rabies vaccine prepared on vero cells 0.5ml prefilled syringe.

The generic manufacturing strategies of New Drug Rabies Vaccine and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.

The Indian company is eminent manufacturer, supplier and exporter of Rabies Vaccine and various pharmaceuticals generics medicines in Tablets, capsules, Vial (injections), ampule, Strips and schedule packs etc.

The companies integrated research team facilitates the affordable production of the drug for even non-regulated markets of the world. i.e. Middle East, Thailand, Bangladesh etc.
