13th July 2010, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Somatostatin Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Octreotide 50mcg 1ml, Octreotide 100mcg 1ml, Octreotide 0.05mg 1ml, Somatostatin acetate 3mg 1ml, Somatostatin acetate 250mcg 1ml.

The generic manufacturing strategies of New Drug Somatostatin and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
