The company is said to have approvals for different combinations of the drug, i.e. Sucralfate 1000mg, Oxethazanine 20mg (100ml), Sucralfate 1gm, Sucralfate 1000mg, oxetacaine 20mg per 10ml, Sucralfate 1gm/10ml, Sucralfate 1gm, oxyethazine 20mg/10ml, Sucralfate 1gm/10ml.
