13th July 2010, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Sodium Fusidate Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Fusidic acid 2% w/w 10gm, Fusidic acid 20mg, betamethasone valerate 1mg 10gm, Fusidic acid 20mg per gm 5gm, Sodium fusidate 2% 5gm, Sodium fusidate 20mg/gm 10gm, Fusidic acid 20mg, chlorocresol 0.12mg per gm 5gm, Fusidic acid 20mg, betamethasone valerate 1.2mg/gm 5gm.

The generic manufacturing strategies of New Drug Sodium Fusidate and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
