20th June 2010, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Silver Sulfadiazine Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Silver sulphadiazine 1% w/w, chlorhexidine gluconate 0.2% w/w 10gm, Silver sulphadiazine 1% w/w, chlorhexidine gluconate 0.2% w/w, aloe 15% w/w, allantoin 0.1% w/w 20gm, Silver sulphadiazine 1% w/w, chlorhexidine gluconate 0.2% w/w, metronidazole 1% w/w, zinc oxide 2.5% w/w 30gm, Silver sulphadiazine 1% w/w 15gm, Silver sulphadiazine 1% w/w, chlorhexidine hcl 0.5% w/w 10gm.

The generic manufacturing strategies of New Drug Silver Sulfadiazine and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.

The Indian company is eminent manufacturer, supplier and exporter of Silver Sulfadiazine and various pharmaceuticals generics medicines in Tablets, capsules, Vial (injections), ampule, Strips and schedule packs etc.
