The company is said to have approvals for different combinations of the drug, i.e. Terfenadine 30mg/5ml, Terfenadine 60mg, Terfenadine 120mg, Terfenadine 60mg, pseudoephedrine 120mg, Terfenadine 30mg, dextromethorphan HBr 30mg/5ml.

The generic manufacturing strategies of New Drug Terfenadine and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
