5th September 2010, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Tetanus Toxoid Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Tetanus toxoid > 5 LF to < 25 LF per 0.5ml, Tetanus antitoxin 750 iu, Tetanus antitoxin 1500 iu, Tetanus antitoxin 5000 iu, Tetanus antitoxin 10000 iu, Tetanus antitoxin 20000 iu, Tetanus antitoxin 50000 iu.

The generic manufacturing strategies of New Drug Tetanus Toxoid and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
