5th September 2010, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Tetracycline Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Tetracycline hcl 250mg, Tetracycline hcl 500mg, Tetracycline hcl 333mg, Oxytetracycline hcl 50mg, lidocaine 2% per ml, Tetracycline hcl 50mg, Oxytetracycline hcl 250mg, thiamine mononitrate 2.5mg, riboflavine 2.5mg, niacinamide 25mg, pyridoxine hcl 0.5mg, calcium pantothenate 5mg, vit B12 3mcg, folic acid 0.375ng.

The generic manufacturing strategies of New Drug Tetracycline and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
