The company is said to have approvals for different combinations of the drug, i.e. Thiocolchicoside 4mg, Thiocolchicoside 8mg, Thiocolchicoside 4mg/2ml, Thiocolchicoside 8mg, aceclofenac 100mg, Thiocolchicoside 8mg, diclofenac potassium 50mg.

The generic manufacturing strategies of New Drug Thiocolchicoside and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
