20th February 2006, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Alphagalactosidase Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Alpha-galactosidase 150mg, Alpha-galactosidase 50unit/ml (30ml), Alpha-galactosidase 200mg, lactase enzyme 7mg, protease enzyme 25mg, amylase enzyme 50mg, lipase enzyme 3mg, Alpha-galactosidase 25mg, fungal diastase 50mg, pepsin 10mg, lactase enzyme 7mg (30ml), Alpha-galactosidase 150mg, simethicone 25mg, Alpha-galactosidase 150mg, extract of carica papaya 50mg, extract of aspergillus niger 17.5mg, extract of aspergillus oryzae 20mg, simethicone 25mg, Alpha-galactosidase 150mg, amylase 50mg, proteases 25mg, lipase 3mg, lactase 7mg, Alpha-galactosidase 25mg, diastase 50mg, pepsin 10mg (200ml).

The generic manufacturing strategies of New Drug Alphagalactosidase and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
