The company is said to have approvals for different combinations of the drug, i.e. Atropine sulph. 1%, prednisolone 0.25%, chlorobutanol 0.5% (5ml), Atropine sulph. 1%, sod. Chl. 0.75%, phenyl mercuric nitrate 0.002% w/v (5ml), Atropine sulph. 10mg, tetracycline 10mg (3g), Atropine sulph. 1% w/v, dexamethasone sod. Phos. 0.1% w/v, phenylmercuric nitrate 0.002% w/v (10ml), Atropine sulph. 1% w/v, chlorbutol 1% w/v (5ml), Atropine sulph. 1% w/v, chlorbutol 0.5% w/v (5ml), Atropine sulph. 1% w/v (5g), Atropine sulph. 1%, dexamethasone sod. Phos. 0.1% w/v (5ml), Atropine sulph. 1%, dexamethasone sod. Phos. 0.1%, chloramphenicol 0.5% w/v (5ml).

The generic manufacturing strategies of New Drug Atropine Eye Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
