19th March 2007, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Butenafine Hcl Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Butenafine hcl 1% w/w (15gm), Butenafine hcl 1% w/w, betamethasone dipropionate 0.05% (15gm).

The generic manufacturing strategies of New Drug Butenafine Hcl and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
