31st January 2007, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Betamethasone Valerate Cream/oint Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Betamethasone valerate 0.05% w/w, gentamicin 0.1% w/w, tolnaftate 1% w/w, iodochlorhydroxyquinoline 1% w/w (5gm), Betamethasone valerate 0.1% w/w (20gm), Betamethasone valerate 0.12% w/w, gentamicin 0.10% w/w, miconazole nitrate 2.0% w/w (20gm), Betamethasone valerate 0.12% w/w, salicylic acid 3.0% w/w (20gm), Betamethasone valerate 0.12% w/w, neomycin sulph 0.5% w/w (20gm), Betamethasone valerate 0.61mg, gentamicin 1mg, tolnaftate 15mg, iodochlorhydroxyquinoline 15mg (5gm), Betamethasone valerate 0.12% w/w, neomycin sulph 0.5% w/w (20gm), Betamethasone valerate 0.5% w/w, gentamicin sulph. 0.1%, tolnaftate 1%, iodochlorhydroxyquinoline 1% w/w (5gm), Betamethasone valerate 0.061% w/w, gentamicin sulph. 0.1%, tolnaftate 1%, iodochlorhydroxyquinoline 1% w/w (5gm), Betamethasone valerate 1mg, fusidic acid 20mg (10gm), Betamethasone valerate 0.12% w/w, miconazole nitrate 2% w/w, neomycin sulph 0.5% w/w (10gm), Betamethasone valerate 0.12% w/w (20ml).

The generic manufacturing strategies of New Drug Betamethasone Valerate Cream/oint and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
