5th March 2007, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Brimonidine Tartrate Eye Drops Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Brimonidine tartrate 2mg/ml (5ml), Brimonidine tartrate 2mg, benzalkonium chloride 0.05mg, polyvinyl alcohol 14mg/ml (10ml), Brimonidine tartrate 2mg, timolol maleate 5mg per ml (5ml), Brimonidine tartrate 2mg per ml (5ml), Brimonidine tartrate 0.2% w/v 5ml.

The generic manufacturing strategies of New Drug Brimonidine Tartrate Eye Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
