The company is said to have approvals for different combinations of the drug, i.e. Beclomethasone dipropionate 0.025% w/w, Beclomethasone dipropionate 0.025% w/w chionoform (quiniodochlor) 3%w/w (15gm), Beclomethasone dipropionate 0.025% w/w, neomycin sulph. 0.5% w/w (15gm), Beclomethasone dipropionate 0.1% w/w, salicylic acid 3% w/w (15gm), Beclomethasone dipropionate 0.025% w/w, clotrimazole 1% w/w, gentamicin 0.1% w/w (10gm), Beclomethasone 0.025% w/w, clotrimazole 1% w/w, neomycin 0.5% w/w (15gm), Beclomethasone dipropionate 0.025% w/w, gentamicin 0.1% w/w, econazole nitrate 1% w/w (10gm), Beclomethasone dipropionate 0.05% w/w (15gm), Beclomethasone dipropionate 0.025% w/w, clotrimazole 1% w/w, gentamicin 1% w/w, chionoform 2% w/w (15gm), Beclomethasone dipropionate 0.025% w/w, neomycin sulph. 3400 iu, polymyxin b sulph. 5000 iu, zinc bacitracin 400 iu (15gm), Beclomethasone dipropionate 0.025% w/w, gentamicin sulph. 0.1%w/w, clotrimazole 1% w/w (15gm), Beclomethasone dipropionate 0.025% w/w, gentamicin sulph 0.10% w/w, clotrimazole 1% w/w, iodochlor hydroxyquinoline 1% w/w (10gm), Beclomethasone dipropionate 0.025% w/w, gentamicin sulph. 0.1%w/w, tolnaftate 1% w/w, iodochlorhydroxy quinoline 1% w/w, chlorocresol 0.1% w/w (5gm), Beclomethasone dipropionate 0.025% w/w, clotrimazole 1%w/w, neomycin sulph. 0.5% w/w, chlorocresol 0.1% w/w (10gm).

The generic manufacturing strategies of New Drug Betamethasone Dipropionate Cream/oint and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
