23rd October 2007, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Clotrimazole Cream/lotion/powder Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Clotrimazole 1% w/w 75g, Clotrimazole 2% w/w 30g, Clotrimazole 10mg (15g), Clotrimazole 1% 15ml, Clotrimazole 1% w/w, beclomethasone dipropionate 0.025% w/w 15g, Clotrimazole 1% w/w, beclomethasone dipropionate 0.025% w/w, gentamicin 0.1% w/w 5g, Clotrimazole 1% w/w, beclomethasone 0.25% w/w, neomycin 0.5% w/w 15g.

The generic manufacturing strategies of New Drug Clotrimazole Cream/lotion/powder and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
