2nd August 2007, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Chloramphenicol Ear Drops Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Chloramphenicol 5% w/v, benzocaine 1%w/v (5ml), Chloramphenicol 5% w/v, beclomethasone dipropionate 0.025%w/v, clotrimazole 1%w/v, lidocaine hcl 2%w/v (5ml), Chloramphenicol 0.5% w/v, dexamethasone sod phosphate 0.1%w/v, phenylmercuric nitrate 0.002% w/v (5ml), Acetic acid 2%, chloramphenicol 5%, lignocaine hcl 2%, prednisolone 0.5% (5ml).

The generic manufacturing strategies of New Drug Chloramphenicol Ear Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
