The company is said to have approvals for different combinations of the drug, i.e. Cyclopentolate hcl 1% w/v, dexamethasone sod. phos. 0.1% w/v 3ml, Cyclopentolate hcl 1% w/v 5ml, Cyclopentolate hcl 1% w/v, chlorobutanol 0.5% w/v 5ml, Cyclopentolate hcl 1% w/v, phenylephrine hcl 5% w/v 5ml.

The generic manufacturing strategies of New Drug Cyclopentolate Eye Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
