The company is said to have approvals for different combinations of the drug, i.e. Cetirizine 5mg, phenylpropanolamine hcl 25mg, paracetamol 500mg, Cetirizine 2mg, phenylpropanolamine hcl 12mg, dextromethorphan 10mg, menthol 1.5mg (100ml), Cetirizine 5mg, dextromethorphan hcl 10mg, Cetirizine 5mg, pseudoephedrine 120mg, nimesulide 100mg, Cetirizine 2mg, pseudoephedrine 15mg, paracetamol 125mg (60ml), Cetirizine 5mg, ambroxol 60mg, Cetirizine 2.5mg, ambroxol 30mg/5ml (50ml), Cetirizine 5mg, paracetamol 500mg, phenylephrine 10mg, caffeine 30mg, Cetirizine 2.5mg, ambroxol 30mg/5ml (100ml).

The generic manufacturing strategies of New Drug Cetirizine With Other Combinations and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
