25th September 2007, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Ciprofloxacin Eye Drops Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Ciprofloxacin 0.3% (10ml), Ciprofloxacin 0.3%, dexamethasone 0.1% (5ml), Ciprofloxacin 0.3%, dexamethasone 0.1% w/v (5ml), Ciprofloxacin 0.3%, dexamethasone 0.1%, benzalkonium chloride soln. 0.02% (5ml).

The generic manufacturing strategies of New Drug Ciprofloxacin Eye Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
