The company is said to have approvals for different combinations of the drug, i.e. Ciprofloxacin 250mg, Ciprofloxacin 500mg, Ciprofloxacin 750mg, Ciprofloxacin 200mg/100ml (100ml), Ciprofloxacin 2mg/ml (100ml), Ciprofloxacin 1000mg, Ciprofloxacin 400mg/200ml (200ml), Ciprofloxacin 100mg/50ml (50ml).
