29th January 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Diloxanide Furoate Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Diethyl carbamazine citrate 50mg, Diethyl carbamazine citrate 100mg, Diethyl carbamazine citrate 120mg/5ml (100ml), Diethyl carbamazine citrate 50mg/5ml (60ml), Diethyl carbamazine citrate 100mg, chlorpheniramine maleate 2.5mg/5ml (100ml), Diethyl carbamazine citrate 150mg, chlorpheniramine maleate 2.5mg, Diethyl carbamazine citrate 50mg, chlorpheniramine maleate 1.25mg, Diethyl carbamazine citrate 250mg, chlorpheniramine maleate 5mg.

The generic manufacturing strategies of New Drug Diloxanide Furoate and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
