The company is said to have approvals for different combinations of the drug, i.e. Divalproex sodium 250mg, Divalproex sodium 500mg, Divalproex sodium 250mg ER, Divalproex sodium 500mg ER, Divalproex sodium 125mg, Divalproex sodium 750mg, Divalproex sodium 1000mg, Divalproex sodium 1g, Divalproex sodium 750mg ER .
