5th February 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Doxylamine Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Doxylamine succinate 10mg, Pyridoxine hcl 10mg, Doxylamine succinate 10mg, Pyridoxine hcl 10mg, Folic acid 2.5mg, Doxylamine succinate 20mg, Pyridoxine hcl 20mg.

The generic manufacturing strategies of New Drug Doxylamine and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
