The company is said to have approvals for different combinations of the drug, i.e. Dexamethasone phosphate 0.1%, chloramphenicol 1% 10ml, Dexamethasone phosphate 0.1%, gentamicin 0.3% 10ml, Dexamethasone phosphate 0.1%, neomycin 0.5% 10ml, Dexamethasone phosphate 0.1%, neomycin sulph. 0.5%, benzalkonium chloride 0.02% w/v per ml 3ml, Dexamethasone 0.1%, chloramphenicol 1%, chlorobutanol 0.5% w/v 5ml, Dexamethasone phosphate 0.1%, neomycin sulph. 0.35%, benzalkonium chloride 0.002% 5ml, Dexamethasone sod. Phos. 0.01% 10ml, Dexamethasone Phos. 0.1%, neomycin sulphate 0.5%, benzalkonium chloride 0.02% 5ml, Dexamethasone sod phos 1mg, chloramphenicol 10mg 5g, Dexamethasone sod. Phos. 1mg, chloramphenicol 10mg, polymixin b sulphate 5000 iu 5ml, Dexamethasone sod. Phos. 1mg, chloramphenicol 10mg, polymixin b sulphate 5000 iu 5g, Dexamethasone sod. Phos. 0.05%, phenyl mercuric nitrate 0.001% w/v 5ml, Dexamethasone sod. Phos. 0.01% w/v 5ml.

The generic manufacturing strategies of New Drug Dexamethasone Eye Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
