4th March 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Electrolytes Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Dextrose anhydrous 5gm, sod acetate 0.64gm, sod chl 0.50gm, pot chl 75mg, sod citrate 75mg, cal chl 35mg, magnesium chl 31mg, sod metabisulphite 20mg/100ml/500ml, Dextrose anhydrous 5gm, sod chl 0.37gm, pot chl 0.13g, amm chl 0.37gm, sod sulphite 15mg per 100ml/500ml, Dextrose anhydrous 5gm, pot chl 0.15gm, dibasic pot phos 0.13gm, sod chl 91mg, sod acetate 0.28gm, sod metabisulphite 21mg per 100ml/500ml, Dextrose anhydrous 5gm, pot chl 0.13gm, dibasic pot phos 0.026gm, sod acetate 0.32g, magnesium chl 0.031gm, sod metabisulphite 0.021g per 100ml/500ml, Dextrose anhydrous 5gm, sod acetate 0.64gm, pot chl 0.12gm, sod chl 0.088gm, cal chl 0.055gm, magnesium chl 0.031gm, sod metabisulphite 0.020gm/100ml/500ml, Sod. 140, chl 103, pot 10, acetate 47, cal 5, cit 8, magn 8 (milli equiv of ions) per 100 ml/540ml, Sod. 63, pot 17, amm 70, chl 150 (milli equiv of ions) per 100 ml/540ml, Sod. 40, pot 35, chl 40, acetate 20, phos 15 (milli equiv of ions) per 100 ml/540ml, Polymer from degraded gelatin (equiv to nitrogen content of 0.63g) 3.5g, electrolyte (Na 145, K 5.1, Ca 12.5, Cl 145 all expressed in mEq per litre) and sterile distilled water to 100ml made isotonic with polypeptide i.v. soln./500ml, Dextrose 5g, sod chl 0.37g, pot chl 0.13g, amm chl 0.37g, sod sulphite 15mg/100ml/500ml, Dextrose 5g, pot chl 0.15g, dibasic pot phos 0.13g, sod chl 100mg, sod acetate 0.25g, sod metabisulphite 21mg, water for injection qs/100ml/500ml, Dextrose 5g, pot chl 130mg, dibasic pot phos 25mg, sod acetate 320mg, mag chl 31mg, sod metabisulphate 21mg per 100ml/500ml, Dextrose 5g, sod acetate 0.33g, pot chl 0.12g, sod chl 0.088g, cal chl 0.055g, mag chl 0.031g, sod metabisulphate 0.0201 g per 100ml/500ml, Each 100ml contains: Polymer from degraded gelatin 3.5gm, electrolyte in m. mol/litre Na 145, K 5.1, Ca 6.25, Cl 145, water for inj qs 500ml.
