29th April 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Fluocinolone Acetonide Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Fluocinolone acetonide 0.025% w/w, ciprofloxacin 0.5% w/w, clotrimazole 1% w/w 20gm, Fluocinolone acetonide 0.025% w/w, povidone iodine 1% w/w 15gm, Fluocinolone acetonide 0.025% w/w, econazole nitrate 1% w/w, gentamicin 0.1% w/w 5gm, Fluocinolone acetonide 0.025% w/w 15gm, Fluocinolone acetonide 0.025% w/w, neomycin sulph. 0.5% w/w 15gm, Fluocinolone acetonide 0.01% w/w, miconazole nitrate 2% w/w 15gm.

The generic manufacturing strategies of New Drug Fluocinolone Acetonide and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.

The Indian company is eminent manufacturer, supplier and exporter of Fluocinolone Acetonide and various pharmaceuticals generics medicines in Tablets, capsules, Vial (injections), ampule, Strips and schedule packs etc.
