2nd May 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Fluticasone Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Fluticasone 50mcg / puff 200 md, Fluticasone 50mcg / puff 200 md, Fluticasone 25mcg / puff 200 md, Fluticasone 0.5mg / 2ml, Fluticasone 2mg / 2ml, Fluticasone 50mcg, Fluticasone 100mcg, Fluticasone 250mcg, Fluticasone 50mcg/spray 100md, Fluticasone 0.05% 100ml.

The generic manufacturing strategies of New Drug Fluticasone and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
