The company is said to have approvals for different combinations of the drug, i.e. Gatifloxacin 0.3% w/v 10ml, Gatifloxacin 0.3% w/v, dexamethasone 0.1% w/v 5ml, Gatifloxacin 0.3% w/v, prednisolone acetate 1% w/v 5ml.

The generic manufacturing strategies of New Drug Gatifloxacin Eye Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
