15th June 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Gliclazide Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Gliclazide 80mg, Gliclazide 30mg, Gliclazide 60mg, Gliclazide 40mg, Gliclazide 30mg CR, Gliclazide 60mg CR, Gliclazide 160mg, Gliclazide 41.6mg, lactose 47.40mg, microcrystalline cellulose 26mg, starch maize 33.5mg, povidone 2.5mg, talc purified 1.60mg, sod. Starch glycolata 1.60mg, magnesium stearate 0.80mg, Gliclazide 82mg, lactose 34mg, microcrystalline cellulose 12mg, starch maize 19mg, povidone 4mg, talc purified 1.60mg, sod. Starch glycolata 1.60mg, magnesium stearate 0.80mg, Gliclazide 30mg extended release, Gliclazide 60mg extended release.

The generic manufacturing strategies of New Drug Gliclazide and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
