24th June 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Glyceryl Trinitrate Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Glyceryl trinitrate 2.6mg CR, Glyceryl trinitrate 6.4mg CR, Glyceryl trinitrate 0.5mg, Glyceryl trinitrate 2.5mg, Glyceryl trinitrate 6.5mg, Glyceryl trinitrate 0.4mg/puff, Glyceryl trinitrate 5mg/ml 5x10ml, Glyceryl trinitrate 2% 30g, Glyceryl trinitrate 25mg/5ml, Glyceryl trinitrate 50mg/5ml, Glyceryl trinitrate 50mg/10ml, Glyceryl trinitrate 5mg, Glyceryl trinitrate 10mg, Glyceryl trinitrate 0.45mg/puff.

The generic manufacturing strategies of New Drug Glyceryl Trinitrate and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
