10th June 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Gammabenzene Hexachloride Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Gammabenzene hexachloride 1% w/v, cetrimide 0.1% w/v 50ml, Gammabenzene hexachloride 1% w/v 100ml, Gammabenzene hexachloride 1% w/v, cetrimide 0.5%w/v 100ml, Gammabenzene hexachloride 1% w/w, benzocaine 2% w/w 25gm.

The generic manufacturing strategies of New Drug Gammabenzene Hexachloride and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
