The company is said to have approvals for different combinations of the drug, i.e. Gentamicin 0.3% w/v 5ml, Gentamicin 0.3% w/v, clotrimazole 1% w/v, beclomethasone 0.025% w/v, lignocain hcl 2% w/v 5ml, Gentamicin 0.3% w/v, dexamethasone 0.1% 5ml, Gentamicin 0.3% w/v 5ml, Gentamicin 0.3% w/v, betamethasone 0.1% 5ml, Gentamicin 0.3% w/v, hydrocortisone 1% 5ml, Gentamicin 0.3% w/v, betamethasone sod phos. 0.1% w/v, benzalkonium chloride 0.02% 5ml, Gentamicin 0.3% w/v, hydrocortisone acetate 1% w/v, benzalkonium chloride 0.04% 5ml.

The generic manufacturing strategies of New Drug Gentamicin Eye Drops and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
