The company is said to have approvals for different combinations of the drug, i.e. Hepatitis b surface antigen protein 10mcg/0.5ml, Hepatitis b surface antigen protein 20mcg/1ml, Hepatitis b surface antigen protein 20mcg/ml 10ml.

The generic manufacturing strategies of New Drug Hepatitis B Surface Antigen Protein and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
