24th July 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Hydrocortisone Acetate Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Hydrocortisone acetate 1% w/w, quiniodochlor 4% w/w 5gm, Hydrocortisone acetate 0.25% w/w, crotamiton 10% w/w 10gm, Hydrocortisone acetate 1% w/w 10gm, Hydrocortisone acetate 1% w/w, miconazole nitrate 2% w/w 5gm, Hydrocortisone acetate 0.003 g w/w, 5 bromosalicyl-4-chloranilide 0.03g, bamipine 0.005gm per gm 10gm, Hydrocortisone acetate 10mg, polymyxin b sulph. 5,000 u, neomycin sulph 3,400 u, zinc bacitracin 400 u per gm, Hydrocortisone acetate 5.58mg, framycetin sulph. 10mg, heparin 100 iu, esculoside 10mg, ethylaminobenzoate 10mg, butylaminobenzoate 10mg per gm 10gm, Hydrocortisone acetate 2.5% w/w 5gm.

The generic manufacturing strategies of New Drug Hydrocortisone Acetate and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.

The Indian company is eminent manufacturer, supplier and exporter of Hydrocortisone Acetate and various pharmaceuticals generics medicines in Tablets, capsules, Vial (injections), ampule, Strips and schedule packs etc.
