The company is said to have approvals for different combinations of the drug, i.e. Recombinant alpha Interferons 2a 3 million i.u., Interferons β 1a 44mcg, Recombinant human Interferons alpha 2b 3 million i.u., Recombinant human Interferons alpha 2b 5 million i.u., Interferons alpha 2b 3 million i.u., Interferons alpha 2b 5 million i.u..
