6th August 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Ifosfamide Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Ifosfamide 1gm per vial, Each pack contains one vial of ifosfamide 1gm and three amp of mesna 200mg per amp (1 Pack), Ifosfamide 1gm.

The generic manufacturing strategies of New Drug Ifosfamide and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
