Mumbai - 10th September 2008 - Taj Pharmaceuticals today received tentative approval from FDA to manufacture generic version of Ketoconazole

10th September 2008, Indian Pharmaceuticals Company Taj Pharmaceuticals based in Mumbai announced FDA approval for Ketoconazole Generic drug manufacturing for regulatory market and non-regulated market.

The company is said to have approvals for different combinations of the drug, i.e. Ketoconazole 2% w/v (30ml), Ketoconazole 2% w/v, ZPTO 1% (50ml), Ketoconazole 2% w/w, zinc pyrithione 1% w/v per ml (50ml), Ketoconazole 2% w/v, cetrimide 0.5% w/v (50ml), Ketoconazole 200mg.

The generic manufacturing strategies of New Drug Ketoconazole and the product-process of Taj Pharmaceuticals Ltd. are compared and collaborated using data from global Pharmaceuticals manufacturing plants in the UK(Newcastle), US, Korea, Italy, Germany and Japan.
